CHAPTER CXIX.

PARDONS.

SECTION

1. Governor may grant pardons on such condi-tions, and with such limitations, as he thinks proper—may issue warrant to carry pardon into effect.

SECTION

2. Officer executing warrant shall make return to governor, and file copy with clerk of the court in which offender was convicted.

Governor may grant pardons on such conditions and with such limitations as he thinks proper.

Section 1. In all cases in which the governor is authorized to grant pardons, he may, upon the petition of the person convicted, grant a pardon, upon such conditions, and with such restrictions, and under such limitations, as he may think proper, and he may issue his warrant to all proper officers to carry into effect such constitutional pardon; which warrant shall be obeyed and executed instead of the sentence, if any, which was originally awarded.

Officer executing warrant, to make return.

Whenever any convict is pardoned by the governor, or his SEC. 2. punishment is commuted, the officer to whom the warrant for that purpose is issued, after executing the same, shall make return thereof, under his hand, with his doings thereon, to the governor, as soon as may be, and he shall also file with the clerk of the court in which the offender was convicted, an attested copy of the warrant and return, a brief abstract of which the clerk shall subjoin to the record of his conviction.

COUNTY JAILS.

TITLE

SECTION 1. There shall be established and kept in every county, by Jail shall be authority of the board of county commissioners and at the expense of the each county. county, a jail for the safe keeping of prisoners.

SEC. 2. The sheriff of the county; by himself or deputy, shall keep sheriff is keeper the jail and be responsible for the manner in which the same is kept; he of jail keeper. shall keep separate rooms for the sexes, except where they are lawfully

married; he shall provide proper meat, drink and fuel for prisoners. When there is no sufficient jail in any county wherein any when there is no criminal offense has been committed, the examining magistrate upon his jail in any country, prisoner shall own motion or the district judge, upon application of the sheriff, may order be kept, where. any person charged with a criminal offense, and directed to be committed to prison, to be sent to the jail of the county nearest having a sufficient jail; and the sheriff of such nearest county shall, on exhibit of such magistrate or judge's order, receive and keep in custody in the jail of his county, the prisoner ordered to be committed as aforesaid; and the said sheriff shall, upon the order of the district court or a judge thereof, re-deliver such prisoner when demanded.

Any county jail may be used for the safe keeping of any Jails may be used fugitive from justice in this state, in accordance with the provisions of any for safe keeping

of fugitive f.om justice. act of congress, and the jailor shall be entitled to reasonable compensation for the support and custody of such fugitive from the officer having him in custody.

Duties and liabilities of sheriffs and jailors as to prisoners committed under authority of United States. Sec. 5. All sheriffs and jailors to whom any person is sent or committed by virtue of legal process issued by or under the authority of the United States, shall be, and they are required to receive such person into custody, and to keep him safely until discharged by due course of law; and all such sheriffs and jailors offending in the premises, shall be liable to the same pains and penalties, and the parties aggrieved shall be entitled to the same remedies against them or any of them, as if such prisoners had been committed to their custody by virtue of legal process issued under the authority of this state.

United States liable to pay for keeping of such prisoners. SEC. 6. The United States shall be liable to pay for the support and keeping of said prisoners, the same charges and allowances as are allowed for the support and keeping of prisoners committed under the authority of this state.

Prisoners, how to be treated.

SEC. 7. Juvenile prisoners shall be treated with humanity, and in a manner calculated to promote their reformation; they shall be kept, if the jail will admit of it, in apartments separate from those containing more experienced and hardened criminals; the visits of parents, guardians and friends who desire to exert a moral influence over them shall at all reasonable times be permitted.

Jail shall be kept, how—food of prisoners, &c.

SEC. 8. The keeper of such jail shall see that the same is constantly kept in a cleanly and healthful condition, and that strict attention is constantly paid to the personal cleanliness of all the prisoners in his custody, as far as may be, and shall cause the shirt of each prisoner to be washed at least once in each week; each prisoner shall be furnished daily with as much clean water as he shall have occasion for, either for drink or for the purpose of personal cleanliness, and with a clean towel, once a week, and shall be served three times each day with wholesome food, which shall be well cooked and in sufficient quantity.

Prisoners desiring it shall have bible. Sec. 9. The keeper of each jail shall provide, at the expense of the county, for each prisoner under his charge who may be able and desirous to read, a copy of the bible or new testament, and any minister of the gospel disposed to aid in reforming the prisoners, and instructing them in their moral and religious duties, shall have access to them at seasonable and proper times.

Sheriff shall keep calendar of prisoner—calendar shall contain what.

Sec. 10. The sheriffs of the respective counties shall keep a true and exact calendar, or register of all prisoners committed to any jail under their care, and the same shall be kept in a book, to be provided by the county for that purpose; said calendar shall contain the names of all persons committed to prison, the places of abode, the time of their commitment, the cause of their commitment, and the authority that committed them, and if they are committed for criminal offenses, shall contain a description of their persons; and when any prisoner is liberated, said calendar shall state the time when, and the authority by which such liberation took place, and if any prisoner escapes, shall also state particularly the time and manner of said escape.

Shall return copy of calendar to judge at each term of court. SEC. 11. At the opening of each session of the district court within his county, the sheriff shall return a copy of said calendar under his hand, to the judge holding said court, and if any sheriff neglects or refuses to do so, he shall be punished by fine, not exceeding three hundred dollars.

Shall furnish convict with tools, when. SEC. 12. Whenever any person is confined in any jail pursuant to the sentence of any court, if such sentence or any part thereof is, that he be confined at hard labor, the sheriff of the county in which such person is confined, shall furnish such convict with suitable tools and materials to

work with, if in the opinion of such sheriff, the said convict can be profitably employed either in the jail or yard thereof, and the expense of said tools and materials shall be defrayed by the county in which said convict is confined, and said county shall be entitled to his earnings.

Sec. 13. No sheriff, jailor or keeper of any jail, shall, under any pre- Shall not furnish tense, give, sell or deliver to any person committed to any prison for any intoxicating cause whatever, any spirituous liquor, or any mixed liquor, part of which oners. is spirituous, or any wine, eider or strong beer, unless a physician certifies in writing, that the health of such prisoner requires it, in which case he

SEC. 14. Sec. 20. Whenever any person, committed to jail for any cause whatever, is unruly, or disobeys any of the regulations established for the management of jails, the sheriff or keeper may order such prisoner to be kept in solitary confinement and fed on bread and water only, for a period not exceeding twenty days for each offense.

Escaping from jail, how punish-

Sec. 21. If any person who may be in any jail, under sentence of imprisonment in the state prison, shall break jail and escape, he shall be punished by imprisonment in the state prison, for the term of one year, in addition to the unexpired term for which he was originally sentenced.

Escaping from jail, how punish-

SEC. 22. If any person under sentence of imprisonment in the county jail, or any person committed for the purpose of detaining him for trial, for any offense not capital, shall break jail and escape, he shall be imprisoned in the county jail for the term of six months.

Person imprisoned for capital offence, escapinghow punished.

Sec. 23. If any person committed to jail for the purpose of detaining him for trial, for a capital offense, shall break jail and escape, he shall be imprisoned in the state prison, for the term of two years.

Sec. 24. If any jail, or any building thereto attached, takes fire, and the prisoners are exposed to danger by such fire, the keeper may remove them to a place of safety, and there confine them, so long as may be necessary to avoid such danger, and such removal and confinement shall not be deemed an escape of such prisoners.

TITLE II.

STATE PRISON.

State prison, lo-cated at Stillwater.

SEC. 25. There shall continue to be maintained for the confinement and reformation of convicts in this state a state prison at Stillwater, in the county of Washington.

Shall be under the control of three directors governor.

The said prison shall be under the direction and govern-Sec. 26. ment of three inspectors, one of whom shall be appointed annually by the appointed by the governor, by and with the consent of the senate, and shall hold his office for the term of three years, and until his successor is appointed and qualified, and shall take and subscribe the oath required by law before entering upon the duties of his office.

Inspectors shall meet, where.

SEC. 27. The board of inspectors shall hold their meetings at the office of the prison, and at their first meeting held after the appointment of each inspector, shall choose one of their number president.

Officers of the prison, who are.

Sec. 28. The officers of the prison shall consist of one warden, who shall be principal keeper of the prison and clerk of the board of inspectors; one deputy warden, who shall be chief turnkey, and both of whom shall reside at the prison; one physician and one chaplain, and such number of assistant keepers and guards as the warden and inspector deem requisite.

Warden shall be appointed by governor and serve two years.

Sec. 29. The warden shall be appointed by the governor, by and with the consent and advice of the senate, and shall hold his office for the term of two years, and until his successor shall be appointed and qualified, unless sooner removed by the governor.

Other officers, how appointed— term of office.

The chaplain and physician shall be appointed by the board of inspectors, and shall hold their respective offices during the pleasure of the board; the deputy warden and assistant keepers and guards shall be appointed by the warden, with the assent of the inspectors, and shall hold their offices during the pleasure of the warden.

The inspectors from time to time shall inquire into and ex-Inspectors shall amine all matters connected with the government, discipline and police of ters connected. the prison, the punishment and employment of the prisoners confined with prison. therein, and they may from time to time require reports from the warden in relation to any and all of said matters.

SEC. 32. They shall inquire into any improper conduct alleged to have Shall inquire been committed by the warden or any other officers of the prison, and for into conduct of officers—may that purpose the president of the board has power to issue subpoenas to subpoena with compel the attendance of witnesses and the production of papers and nesses. writings before them, in the same manner and with the like effect as in cases of arbitration.

Sec. 35. The board of inspectors shall keep regular minutes of their Shall keep minproceedings and meetings, which shall be signed by the president, and utes of their proceedings attested by their clerk.

SEC. 41. They shall appropriate annually, out of fees received from visitors or from other funds of the prison, a sum not less than twenty-five dollars, to be expended in the purchase of books or periodicals, for the use of the prison library.

Salaries of officers of prison.

1871-100 1874-131 SEC. 42. There shall be paid to the officers of the prison, the following salaries and compensation, to be paid quarterly out of the state treasury, on the warrant of the auditor, to wit: to the warden the sum of seven hundred and fifty dollars; to the deputy warden the sum of four hundred dollars; to the inspectors the sum of two dollars per day, for each day necessarily employed in the discharge of their duties: to the chaplain and physician and assistant keepers and guards such sums as the board of inspectors deem proper and just.

Warden and deputy shall file oath and bond with secretary of state. Sec. 43. The warden and deputy warden shall, before entering upon the duties of their offices, file in the office of the secretary of state, the proper oath, together with a bond executed to the people of this state, with two or more sureties, duly approved by the governor; the warden in the sum of twelve thousand dollars, and the deputy warden in the sum of five thousand dollars, conditioned for the faithful performance of their duties according to law.

Duties of warden.

Sec. 44. The warden shall attend constantly at the prison except when performing some other duty connected with his office; he shall exercise general supervision over, and give necessary directions to, the keepers and guards; examine whether they have been vigilant in the discharge of their respective duties; examine daily into the health of prisoners, and take charge of the real and personal estate belonging to or connected with the prison.

Transactions with prison, how conducted—actions, how brought.

Sec. 45. All the transactions and dealings of the prison shall be conducted in the name of the warden, who shall be capable in law of suing and being sued in all courts and places in all matters concerning the said prison, by his name of office; and by that name he is hereby authorized to sue for and recover all sums of money or any property due from any person to any former warden of said prison or to the people of this state, on account of said prison.

Shops and grounds may be leased.

Sec. 46. The shops and such vacant grounds as the inspectors deem proper may be leased by the inspectors and warden to parties from whom they obtain the highest and best price, and for such length of time as they may deem for the interest of the state, but not for a longer term than three years at any one time.

Convicts may be let to service.

Sec. 47. The warden and inspectors may let to service all able bodied convicts confined in the prison, except such as are precluded by the terms of their sentence, to the lessee of the prison shops and fixtures, for such a term of years as they deem proper, not to exceed three years at any one time, for the highest and best price they can obtain: provided, such contract shall be approved by the governor and auditor of state.

Rents, &c., of shops to be paid into state treas-

Sec. 48. The rents, revenues and profits derived from the leasing of the prison shops, grounds and convict labor, together with all charges for maintaining other than state convicts, shall be paid to the warden and by him paid into the state treasury.

Provisions, &c., how furnished.

SEC. 49. The necessary provisions, fuel, lights, clothing, bedding, medicines, and all other supplies for the prison, shall be furnished by contract when the same is practicable, to be made by the warden under the direction of the inspectors, with such persons as will furnish the same on the best terms.

Contracts by warden, how made. Sec. 50. All contracts made by the warden shall be reduced to writing, and a copy of the same shall be submitted to the inspectors at their first meeting held thereafter, and a copy filed in the office of the prison.

SEC. 51. No officer of the prison shall employ the convicts on a work officers not to be in which he or any other officer has a personal interest, nor be connected interested in business, &c. with or have any interest in the business or shops belonging to the prison.

When any convict offers violence to any officer or guard of officers shall rethe prison, or to any other person or convict, or attempts to do any injury press attempted violence by conto the buildings or any workshop, or to any appurtenances thereof, or dis-viets. obeys and resists any reasonable command of any officer or guard, such officers and guards shall use all reasonable means to defend themselves, and to enforce the observance of discipline.

SEC. 57. If any convict resists the authority of any officer, keeper, Convict resisting or guard of the prison, or refuses to obey any lawful command, such offi-authority of officers, keeper or guard shall immediately enforce obedience by the use of in consequence. such weapons or other aid as may be necessary for the purpose, and if in officers held guiltso doing any convict thus resisting shall be necessarily wounded or killed by such officer or his assistants, they are justified and shall be held guiltless.

SEC. 58. In case any pestilent or contagious disease breaks out among Convicts may be the convicts in the prison, the inspectors and warden may cause such confined diswhere, victs to be removed to some secure and suitable place, where such as are when. sick shall receive all necessary care and medical attendance.

SEC. 59. Sec. 61. When any convict is discharged from prison, the warden shall furnish such convict with a decent suit of clothes, (if he is not already provided for,) at the expense of the state, and shall pay such convict from any funds belonging to the prison, a sum of money not exceeding The warden shall furnish at the expense of the state, a bible to each convict who can read.

Each prisoner shall have separate cell.

Sec. 62. Whenever there are cells sufficient, each prisoner shall be confined in a separate cell.

Warden may conconvicts elsewhere, when.

In case the number of prisoners is so great as in the opinion Sec. 63. tract for keeping of the warden and inspectors to render it impossible to keep them securely at the state prison, the warden may make a contract with the county commissioners of the county of Washington or Ramsey, to confine and maintain such prisoners as cannot be securely kept in the state prison, in the jail of their county, and may bind the state to pay such reasonable sum as he may agree upon with such county commissioners for the custody and maintenance of such prisoners, and in such case the written warrant of the warden of the state prison shall be a sufficient authority for the sheriff of such county to receive and restrain in the jail of his county any such prisoner.

Convicts shall be supplied with clothing, &c.

Sec. 64. The clothing and bedding for the convicts shall be of coarse material, and they shall be supplied with a sufficient quantity of substantial and wholesome food.

No communication allowed with convicts except by consent of warden.

SEC. 65. No person shall, without the consent of the warden, bring into or carry out any writing or any information to or from any convict.

at pleasure

The following persons shall be allowed to visit the prison at pleasure: the governor, lieutenant governor, members of the legislature, Certain persons may visit prison all state officers and regularly authorized ministers of the gospel, but no other person shall go within the walls of the prison, without the special permission of the warden.

Certified copy of sentence to be de-livered to warden with convict.

SEC. 67. When any convict is delivered to the warden, the officer having such prisoner in charge shall deliver to the warden a certified copy of the sentence received by such officer, from the clerk of the court where such convict was tried, and shall take from the warden a certificate of the delivery of such convict, and such certified copy of the sentence shall be evidence of the facts therein contained.

Convict escaping, warden shall offer reward.

When any convict escapes from the prison, the warden shall SEC. 68. use all proper means for the apprehension of such convict, and for this purpose he shall offer a reward not to exceed one hundred dollars, and not less than twenty-five dollars: provided, that if such escape was by reason of the negligence of the warden or of any officer under him, the reward thus offered shall be paid by the warden.

Inspectors shall approve rewards.

Sec. 69. All suitable rewards and other sums of money paid for advertising any convict, shall be approved by the board of inspectors, and paid out of the state treasury.

Expenses and fees of officers shall be paid by state-rate of fees allowed.

Sec. 70. The necessary expenses and legal fees of sheriffs and other officers, incurred in conveying convicts to the state prison, shall be approved by the auditor of state, and shall be paid out of the state treasury. Said auditor may allow for said expenses and fees the following rates: For team and driver employed in conveying convicts to the prison, three dollars per day; for sheriff, three dollars per day; for each assistant or

The warden, deputy warden, inspectors, physician, assistant Officers of prison keepers, and guards, shall be exempt from military and jury duties, while exempt from military and jury actually employed by the state as such officers.

SEC. 75. On the removal or resignation of the warden, the auditor of State auditor to state shall settle the accounts of such warden, on the presentation of his den, when. books, accounts, and vouchers, duly authenticated, for such purpose.

Sec. 76. Whenever there is a vacancy in the office of warden, or the beputy warden to perform duties warden is temporarily absent, all the duties of warden shall devolve upon of warden, when. and be performed by the deputy warden, until the vacancy is filled or the warden returns.

SEC. 77. The physician shall keep a register of all convicts placed Physician shall under his care, the disease with which they are afflicted; also of the death convicts, disease of any convicts, stating their names, age, time, and cause thereof.
