## TITLE 1.

### OF STATE OFFICERS.

For salaries of other state officers, see ch. 6.

SEC. 726. Governor.— The salary of the governor is hereby fixed at five thousand dollars per annum, which shall include house rent.

Secretary to governor.— From and after the passage of this act the salary of the governor's private secretary shall be one thousand five hundred dollars per annum.

Secretary of state.— The salary of the secretary of state "is thirty-five hundred (3500) dollars per annum, which shall also include his salary for super-intending the public printing."

All fees and charges whatsoever hereafter paid into the office of the secretary of state, including all fees received by such officer during the months of January and February, eighteen hundred and eighty-seven (1887) (except fees for notary public appointment, which fees shall be paid to the private secretary of the governor from and after the passage of this act, and remain in force until January first (1st), eighteen hundred and eighty-nine (1889), ) shall be turned over to the state treasury; and it shall be the duty of the secretary of state to make monthly statements in detail to the state auditor of fees received, and to pay the same to the state treasurer according to such statement; *provided*, that the fees so to be paid to the state treasurer, shall include all fees of whatever nature for every service rendered in said office, whether by the secretary, his assistant, or any clerk in the department.

Assistant secretary of state.— The salary of assistant secretary of state is one thousand dollars per annum.

**Clerk in office of secretary of state.**— The secretary of state is hereby empowered to employ in his office a clerk, who shall receive for his services twelve hundred dollars per annum, to be paid out of the state treasury as other clerks of the state department are paid.

**Recording clerk in office of secretary of state.**— The secretary of state is hereby empowered to employ in his office a recording clerk, who shall receive for his services the sum of one thousand (1,000) dollars per annum, and the sum aforesaid is hereby annually appropriated out of any moneys in the treasury belonging to the general revenue fund for the payment of said salary.

State auditor.— The salary of the state auditor is hereby fixed at two thousand dollars per annum.

**Deputy state auditor.**— That the salary of the deputy state auditor be and the same is hereby fixed at twenty five hundred dollars (\$2,500) per annum and said sum is hereby annually appropriated for the payment of the same.

Chief clerk in auditor's office.— That the salary of the chief clerk in the state auditor's office, for the year one thousand eight hundred and eightyone (1881), and annually thereafter, shall be two thousand dollars (\$2,000).

**Bookkeeper in auditor's office.**— That the state auditor is authorized to employ a bookkeeper at a salary of fifteen hundred dollars (\$1,500) per annum.

State treasurer.— The salary of the state treasurer is three thousand five hundred dollars per annum.

Deputy state treasurer.— That the salary of the deputy state treasurer for the year A. D. one thousand eight hundred and eighty-two (1882), and annually thereafter, shall be eighteen hundred dollars (\$1,800).

State treasurer's clerk.— That the sum of twelve hundred (1,200) dollars be and the same is hereby appropriated annually out of any moneys in the treasury belonging to the general revenue fund, for the payment of the salary of the state treasurer's clerk. Which annual salary is hereby fixed at twelve hundred (1,200) dollars.

Attorney general.— That the salary of the attorney general for the year one thousand eight hundred and eighty-five (1885) and annually thereafter shall be thirty-five hundred (3,500) dollars, and, in addition thereto, he shall receive ten dollars per day for each and every day of actual and necessary attendance upon court.

Attorney general's clerk.— The salary of attorney general's clerk is fifteen hundred dollars per annum.

Judges of supreme court.— The judges of the supreme court shall each receive a salary of five thousand (5,000) dollars per annum.

## SALARIES - STATE OFFICERS.

**Clerk of supreme court.**— The salary of the clerk of the supreme court is hereby fixed at fifteen hundred dollars per annum, to be computed at that rate from and after January first, A. D. eighteen hundred and seventythree.

**Deputy clerk.**— The clerk of supreme court is hereby empowered to employ in his office a deputy clerk, who shall receive for his services the sum of one thousand dollars (\$1,000) per annum, and the sum aforesaid is hereby annually appropriated out of any moneys in the treasury belonging to the general revenue fund for the payment of said salary.

**Reporter of supreme court.**— That the reporter of the supreme court be in lieu of the copyright heretofore held by him and as a compensation for his services as such reporter, shall receive an annual salary of fifteen hundred dollars (\$1,500).

**Librarian.**— That the sum of two thousand dollars (\$2,000) be and the same is hereby appropriated annually, out of any moneys in the treasury belonging to the general revenue fund for the payment of the salary of the state librarian, which annual salary is hereby fixed at the sum of two thousand dollars (\$2,000).

Adjutant general.— The salary of the adjutant general for the year one thousand eight hundred and eighty-seven (1887) and annually thereafter shall be two thousand (2,000) dollars per annum, and, in addition thereto, such sum or sums of money as may be by him necessarily expended in the care and management of the arms and other military equipments belonging to the state.

Adjutant general's clerk.— The salary of adjutant general's clerk is twelve hundred dollars per annum.

**Military storekeeper.**— The salary of the military storekeeper is hereby fixed at twelve hundred dollars (\$1,200) per annum from the first (1st) day of January, A. D. eighteen hundred and eighty-three (1883).

Superintendent of public instruction.— That the superintendent of public instruction be required to appoint an assistant, who shall be known as assistant superintendent, to perform such service in the department as may be assigned him by the superintendent, and that his salary be fifteen hundred dollars (\$1500) per annum.

Clerical assistance.— That the superintendent of public instruction be allowed sixteen hundred (1600) dollars per year for necessary clerical assistance.

Land commissioner.— The salary of the state land commissioner is sixteen hundred dollars per annum.

**Clerk in land office.**— That the salary of the clerk of the state land office for the year one thousand eight hundred and seventy-seven, and thereafter be fixed at fifteen hundred dollars per annum.

Assistant clerk.— That the commissioner of the state land office is authorized to employ an assistant land clerk at a salary of twelve hundred dollars (\$1200) per annum.

**Clerk for insurance commissioner.**—The insurance commissioner is hereby empowered to employ, in his office, a clerk, who shall receive for his services fifteen hundred dollars per annum, to be paid out of the state treasury as other clerks of the state department are paid.

### TITLE 2.

#### OF DISTRICT OFFICERS.

SEC. 727. Judges of district court.— The salary of each of the judges of the district court is thirty-five hundred dollars (\$3500) per annum.

#### TITLE 3.

#### OF COUNTY OFFICERS.

For salary probate judge, see ch. 9; county auditor and treasurer, ch. 8; county superintendent of schools, ch. 36.

SEC. 728. Salary of county attorneys .- The county attorneys shall receive a salary of not exceeding two thousand dollars per annum, to be fixed by the board of county commissioners,\* and paid quarterly from the treasury of the county, upon the warrant of the county auditor: provided, that any county attorney feeling himself aggrieved by the act of the county commissioners in fixing such salary, may appeal to the district court of the proper county, by filing with the county auditor thereof a notice of such appeal, within thirty days after such salary shall have been so fixed by such board of commissioners, or, in case the same shall have been fixed at any time prior to the passage of this act, then within thirty days after the passage thereof. And the judge of said court, upon such appeal being taken as aforesaid, shall, either in term time or in vacation, upon the application of such attorney, eight days' notice thereof being given to the chairman of such board of commissioners or the county auditor, proceed to determine such appeal in a summary manner, and shall allow such sum for such salary as he shall deem just and reasonable (not exceeding twelve hundred dollars per annum), and shall make an order therefor, to be filed in the office of the county auditor; and the amount so determined upon shall be the salary of such county attorney, from the time of the fixing of the salary by such county commissioners from which such appeal

was taken, to the end of the term for which such salary was so fixed, and for which such county attorney was elected, unless altered or changed by such court or judge, for good cause shown.

SEC. 729. Salaries payable monthly.— The salaries of the county attorneys, judges of probate and county superintendents of public schools shall be paid monthly from the treasury of the county, upon the warrant of the county auditor.

SEC. 730. Appropriations for salaries.— That the following sums of money, or so much thereof as may be necessary, be and the same are hereby annually appropriated out of any moneys in the treasury belonging to the general revenue fund for the payment of the salaries of the officers of the state government.

Governor.—For salary of the governor, five thousand dollars (\$5,000).
